RO16BTRLRONCRT0241205001, represented by Rizvi Shajjad Hadier as Chairman and Carmen Dragomir as Head of Programme - hereinafter called "THE SPONSEE"

### II. Object of the Contract

The object of this contract is represented by the sponsorship activity of "THE SPONSOR" to financially support "THE SPONSEE" in order to support the development of The Duke of Edinburgh's International Award programme in Romania.

### III. Value of the Contract

### IV. Obligations of "THE SPONSOR"

- 2) "THE SPONSOR" is forbidden to interfere in any way in the activity of "THE SPONSEE".

### V. Rights and Obligations of "THE SPONSEE"

- 1) "THE SPONSEE" has the right to cash the sum of money paid according to this Sponsorship Contract.
- 2) "THE SPONSEE" is obliged to use the obtained financial support exclusively for the purpose mentioned above, that is for the development of The Duke of Edinburgh's International Award programme in România and the organisation of the Royal Gala.
- 3) "THE SPONSEE" is obliged to make public this sponsorship by promoting the name/logo of "THE SPONSOR".



**VI. Transfer of Contract**

None of the parties of thisContract shall transfer the rights and obligations mentioned in thisContract to a third party, without the written consent of the other party.

**VII. Duration of Contract**

This Contract terminates when one of the parties does not perform the obligations above mentioned , without notifying the party beforehand about the termination.

**VIII. Force majeure**

The force majeure protects from liability the party that cites it.

**IX. Disputes**

The possible disputes that may arise from the performance of this Contract shall be resolved out of Court settlement, and if this is not possible, the disputes shall be resolved at the Court in Bucharest.

**X. Final provisions**

Any amendment of this Contractshall be made only in writing and with the consent of both parties.
